The Syndicate vide its Res. No. 15-1.2 dated 22.04.2024 has approved the following amendments in University Regulation 44-F:-

Ref. Equivalence Committee Res. No. 34 dated 03.11.2023 and Special Academic Council Res. No.03 dated 02.12.2023.

The existing provisions of University Regulation 44-F be re-written as under :

All the UG/PG/Diploma/Certificate Academic & Professional courses of the under mentioned Universities/Institutions have been recognized as equivalent to the respective courses being run by the University subject to the provision of the forgoing regulation 44-D :-
